

**Motorcycle Adventure Group, LLC
d.b.a. Women's Motorcycle Tours
Release and Waiver of Liability, Assumption of Risk & Indemnity**



_____ I understand that my consent to these provisions is given in consideration of the acceptance of this registration and for being permitted to participate in this tour. I hereby make the following covenants, promises and representations to the the Motorcycle Adventure Group LLC, d.b.a. Women's Motorcycle Tours (hereinafter referred to as "WMT"), all company sponsors and affiliates, all hotels, motorcycle rental agencies, staff, agents, representatives and volunteers, and all other persons or entities associated with this tour (hereinafter referred to as "Releases").

_____ I am a voluntary participant in this tour. I am at least 18 years of age and have a current motor vehicle driver's license with proper motorcycle endorsement which has not been revoked, suspended or has expired. I am in good physical and mental condition and come to this tour with the stamina and conditioning required to fulfill my participation this tour.

_____ I agree to exercise reasonable care while riding and to observe and obey all traffic laws and safety rules. I acknowledge and support the judgments and decisions made by the WMT staff with regard to changes in the schedule, route and my continued participation as a rider. Adjustments and assessments will be made in light of changes in weather, road conditions and/or my ability to participate in a manner that assists in maintaining my safety and the safety of those around me.

_____ I am aware that it is my sole responsibility to keep the motorcycle in control at all times, to select proper safe speeds for the conditions of travel and for my skill level, and to adhere to all the traffic laws of the countries in with I travel.

_____ I further understand that in addition to this waiver, I will also sign and adhere to the language of waivers provided by the American Motorcyclist Association and any other parties who require waivers to be signed as users of their products as a participant in a WMT tour. These products may include but are not limited to motorcycles, helmets and/or other provided gear.

_____ I am not currently taking any pharmaceutical products or other drugs which may impair my ability to ride and will not ingest any alcoholic beverages prior to or while driving or riding.

_____ If I do not follow the rules of the tour, I understand that I may be removed from the tour by the organizers of this tour and no monies will be refunded to me.

_____ I recognize that this tour must continue even if my motorcycle or my rental motorcycle breaks down or I am injured or I am unable to continue this tour for any reason. I understand that all monies paid to participate in this tour are non-refundable and non-transferable once the tour starts.

_____ I understand that I am required to wear a motorcycle safety helmet at all times on the ride; not just when riding in a group. I also understand that I must wear a motorcycle safety helmet even though a particular state's laws through which we are riding may not require one.

_____ I ACKNOWLEDGE THAT MOTORCYCLE TOURING AND RIDING IS A POTENTIALLY DANGEROUS AND HAZARDOUS ACTIVITY, AND I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH FULL KNOWLEDGE OF THE DANGERS INVOLVED. I HEREBY AGREE TO ASSUME FULL AND COMPLETE RESPONSIBILITY FOR ANY PERSONAL INJURY, PROPERTY DAMAGE, OR DEATH, WHICH MAY OCCUR DURING MY PARTICIPATION IN THIS ACTIVITY. I HEREBY RELEASE, HOLD HARMLESS AND COVENANT NOT TO FILE SUIT AGAINST ANY OF THE RELEASEES FOR ANY LOSS, LIABILITY OR CLAIMS THAT I MAY HAVE ARISING OUT OF MY PARTICIPATION IN THIS TOUR, INCLUDING BODILY INJURY, PROPERTY DAMAGE OR DEATH SUFFERED BY ME OR OTHERS, WHETHER THE SAME BE CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

Additional Terms and Conditions:

- I. Photos and videos taken of me during my tour by WMT personnel may be used wholly or in part in magazines, books, calendars, portfolios, exhibitions, trade shows, and for Internet, editorial and advertising use. The photographs and videos may be used to represent an imaginary person and any wording associates will not be attributed to me personally unless my name is used. I acknowledge that I give up all claims of ownership, income, editorial control and use of the resulting photographs and videos unless a valid licensing agreement has been purchased from WMT. Use of the photographs and videos may be granted to third parties; however the photographs and videos will remain the property of WMT.
- II. I understand Releasees participating with their own or rented motorcycles are solely responsible for conforming to the law and the operating condition of the motorcycle. In the event that WMT incurs any costs including but not limited to motorcycle recovery, safe keeping and repair, that the Releasee is responsible to compensate WMT for any monies spent on my motorcycle on my behalf.
- III. Releasee expressly agrees that this release is intended to be as broad and inclusive as possible as permitted by the laws of California and that if any portion thereof is to be held invalid, it is agreed that the balance shall notwithstanding continue in full force and effect. Further, this release and all agreements, contracts, etc. with WMT shall be governed by the laws of the State of California, United States.
- IV. I have read the Release and Waiver of Liability, fully understand all of its terms, and have signed it freely and voluntarily without inducement. I intend by my signature for this Release and Waiver of Liability to be a complete and unconditional release of all liability to the greatest extent allowed by law. I also understand and agree that this Release and Waiver of Liability shall be binding on my heirs, successors and assigns.
